- 8. The institutions shall not automatically become eligible to receive financial grant/assistance from the Central/State Govt. or any other funding agency.

- The institution shall be visited by an officer or a committee of the university to inspect and review the progress made
 by the institution in fulfilling norms and procedures as laid down by the AICTE/University.
- The institution shall not charge any Capitation fee or donation for admission or other higher charges from students or
 their guardians in any form.
- 13. The institution will have an independent building as per norms of the University with a separate approach.
- 14. This order shall stand cancelled in case the college fails to deposit Affiliation fee (unless specifically exempted) by the due date.
